- Member Business

- Registrar's Report Tina
 - 4-5 who have registered for Spring and to be placed on a team.
 - Record year of 470+.
- Treasurer's Report Brandon
 - All is well. We have financials through February (no March yet, but s/b this week). Cash is healthy, no issues to report.
 - EDP teams received ref fees already, plan is to get CDYSL ref fees out this week for Spring.
 - Trying to work on an overall reconciliation for May Day income (per Tina it s/b \$103k so far).
 - May Day
 - Brandon to prep the ref fees for May Day.
 - Team has been doing a good job of passing along invoices as they're received so that we're
 pretty current there.
 - Trying to make sure that all invoices for winter facilities are in.
 - May be one remaining from Afrim, which will require reconciliation to include the utilities).
 - Adam has an update one from the Dome he'll forward.
 - Annual Budget Prep
 - We can prep in May (after May Day). Just need to put some assumptions down (Coaching, Registration, Indoor time). Brandon to schedule some time w/ key stakeholders.
 - Facility Fund Question
 - Brandon and Ed to meet with bank contacts to start to determine the go-forward plan.
- Coaching
 - Rec Kyle
 - Rec starts tomorrow with 304 registrants!
 - Travel Adam
 - Big picture, we're really competing in the area. As far as the elite level clubs, we're beating
 or better than, no town teams that are developing the talent as we are.
 - Need to push the placement schedule out over the next couple of months to get people at tryouts. June 20-23, 2023 (2x/age group). Registration link s/b up prior to May Day or the week of.
 - We are in a very strong Coaching position standpoint. A few new people who really want to get involved w/ the club. We're not stretching Coaches like we have in the past, which is a really big positive for us.
- Tournaments and Events Adele/Tina
 - $\circ \quad 175 \ teams.$
 - \circ Gavin Park \rightarrow Rental of entire property plus baseball fields. Last year we didn't pay for the latter, not clear if we're to pay for them this year.

- We got approval for lights on Fields 2 & 3 for night games. We have 6 on hold.
- Medic → We have a new one this year (info to be sent to Rachel). Hours and game times have been coordinated with her. Dual coverage for Sat/Sun and just her on Friday (she contacted Wilton EMS to make them aware).
- Volunteer Signup went out today and is completely full. Rachel has an idea on where we can add, need to confirm a few pieces before we can solidify the placements. Changing the front tent to Info only and moving all ticket sales to the shootout area.
 - We may have access for up to 15 walkie talkies.
 - Tina sent an email out to Skelly to confirm we have night games on Friday and Saturday.
- Kyle is working on the schedule (U8/U10/U16 are done). Hope is to have schedule completed by the end of this week.
